In exercise of the powers vested under Section 14(3) (a) of the National Council for Teacher Education(NCTE) Act, 1993, the Eastern Regional Committee grants recognition to Ramakrishna Mission Brahmananda College of Education, Rahara, North 24 Parganas, West Bengal for B.Ed. Course of one year duration from the academic session 2002-2003 with an annual intake of 80 (Eighty) students, subject to fulfilling the following conditions:

- 1. The institution shall appoint / function with 7 teaching staff and supporting staff possessing the qualifications as laid down in the NCTE norms before the commencement of academic session 2002-2003, in the salary structure prescribed by the UGC/Central Government/ State Government as the case may be.
- All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
- 3. The institution shall ensure library, Journals, laboratories and other instructional infrastructure as per the NCTE norms.
- 4 The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/ State Government.
- 5. Tultion fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
- Ourriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/examining body.
- 7 Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
- The institution, being private and unaided, shall maintain endowment fund of Rs. 5 lakhs under the joint operation with the Officer of ERC, NCTE in the Nationalized Bank within one month from the date of receipt of this Order and reserve fund of three months salary as per NCTE norms.
- The Institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Performance Appraisal Report within 45 days of the last examination/academic session every year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 8 above.

If Ramakrishna Mission Brahmananda College of Education, Rahara, North 24 Parganas, West Bengal contravenes any of the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder, or falls to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section (64) of the NCTE Act
