Order

In terms of Section 16(1) of the NCTE Act, 1993 All Bengal Teachers Training College, P14, Ganesh Chandra Avenue, Kolkata, West Bengal, Pin-700 013 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting <u>B.Ed.</u> Course of <u>One</u> year duration from the academic session <u>2004-2005</u> with an annual intake of <u>120 (One hundred twenty)</u> students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - The institution has acquired the land for setting up the teacher education institution and it proposes to shift to its own building.
 - ii) The institution building is under construction on the above mentioned land.
 - iii) The institution has created a Reserve Fund of Rs. 5,03,325/-.
 - iv) The institution has selected the Principal and 04 (four) full-time teachers and 06 (six) teachers on contract basis for the said course and the list of faculty members has also been approved by the affiliating University
- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to All Bengal Teachers Training College, P14, Ganesh Chandra Avenue, Kolkata, West Bengal, Pin-700013 for B.Ed. Course of One year duration from the academic session 2004-2005 with an annual intake of 100 (One hundred) students subject to fulfillment of the following:
 - faculty members as per NCTE norms (or, 5 (five) full-time and 4(four) part-time/ guest lecturers as per relaxation granted by the Council in case of West Bengal up to academic session 2004-2005) duly approved by the affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of commencement of the academic session.
 - b. The faculty not having M.Ed./ M.A.(Education) shall acquire M.Ed. qualification within five years.
 - c. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.
- **4.** Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
