- 3. NOW THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Cooch Behar B.Ed. Training College, Po-Tangonmari (Rajarhat), Dist-Cooch Behar, West Bengal -736101 for conducting B.Ed. - b) It was observed that the list of teaching staff has not been countersigned by the competent authority of the affiliating university, but countersigned by Inspector of Colleges. So, the institution has to submit the list countersigned by competent authority of affiliating University or submit an affidavit of Rs.10/- on non-judicial stamp paper duly attested by Notary/ First Class Magistrate on the prescribed format (attached).
- c) The institution shall pay salary to the teaching staff as prescribed by UGC/University through Account Payee Cheque.
- d) The number of administrative staff shall be maintained as per NCTE norms. The qualifications of technical support staffs shall be maintained as per norms prescribed by concerned affiliating University / UGC. The qualifications of the administrative staff shall be maintained as per norms prescribed by concerned State Govt/affiliating University.
- e) The institution shall, within one month of the receipt of recognition order, convert the Endowment Fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- The reserve fund for an amount of Rs 3.00 lakh be maintained in the rorm of EDR in favour of the management / institution
- g) The institution shall obtain affiliation from the examining body before the commencement of the course.
- h) The institution shall maintain and update their website as per NCTE regulations.
- i) Apart from the qualifications prescribed for teachers for 3 Ed. Course, the candidate shall have to qualify MET/SLET qualifications or alternative qualifications thereto as prescribed by UGC from time to time before the commencement of the academic session 2009.- 2010.

jj The intake, eligibility and admission procedure shall be strictly adhered as per NCTE norms.

- k) Performance Appraisal Report shall be submitted by the end of every academic year on the prescribed format.
- 1) As the affidavit submitted by the institution in the old format, the institution may submit an affidavit of Rs.100/- on non-judicial stamp paper in original on the new format (attached).
- m) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
- 5. The institution shall submit to the Eastern Regional Committee a Self Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Charted Accountant.
- 6. If the institution contravenes only of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Eastern Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
