- 4. Further the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government etc, wherever applicable.
- 5. The institution shall submit the Eastern Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff.
- 6. If the institution contravenes any of the above conditions or are at the provisions of the NCTE Act, Rules Regulations and Orders made or issued thereunder, the Eastern Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
