- c. The number of administrative staff shall be maintained as per NCTE norms. The qualifications of technical support staffs shall be maintained as per norms prescribed by concerned affiliating University / UGC. The qualifications of the administrative staff shall be maintained as per norms prescribed by concerned State Govt/affiliating University.
- d. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- e. The Reserve Fund for an amount of Rs. 3.00 lake be maintained in the form of FDR in favour of the management/institution.
- f. The institution shall obtain affiliation from the examining body before the commencement of the course.
- g. The institution shall maintain and update their website as per NCTE regulations.
- h. The intake, eligibility and admission procedure shall be strictly adhered as per NCTE norms.
- i. Performance Appraisal Report shall be submitted by the end of every academic year on the prescribed format.
- j. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
