#### Order

WHEREAS, Sunil Dhar Memorial B.P.Ed. College, Vill/PO: Panchthupi, P.S.: Borwan, Block-Borwan, Dist:Murshidabad, State: West Bengal, Pin Code: 742161 was granted recognition for conducting B.P.Ed. Course of one year duration with an annual intake of 50(fifty) students vide ERC order No.ERC/7-75.6(I).3/2007/7913 Dt.03.05.2007.

- 2. WHEREAS on the basis of complaint against the institution namely **Sunil Dhar Memorial B.P.Ed. College, Vill/PO: Panchthupi, P.S.: Borwan, Block-Borwan, Dist:Murshidabad, State: West Bengal, Pin Code: 742161**, the Eastern Regional Committee considered the matter in its 93<sup>rd</sup> meeting held on 25-27 February, 2009 and decided to inspect the institution before taking further action U/S 17 of the NCTE Act.
- 3. AND WHEREAS, the inspection of the institution was conducted on 03.06.2009.
- 4. AND WHEREAS, the matter was considered by the ERC in its 97<sup>th</sup> meeting of ERC whereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms.
  - (i) Required number of teaching staff does not possess qualification as per NCTE norms.
  - (ii) Details of total area and land area not given as per norms. Built up area is less than the requirement. Certified/Notarized coy of the registered land documents along with an affidavit on Rs.100/- stamp paper duly attested by the Notary regarding land and building not given.
  - (iii) Language learning lab is not available as per the NCTE norms.
  - (iv) Library books are less than as per NCTE norms.
  - (v) Facilities in the Psychology lab inadequate as per NCTE norms.
- 5. AND WHEREAS the ERC directed that <u>an</u> opportunity be given to the institution to make a written representation within 30 days from the date of issue of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on dt.08.07.2009.

AND WHEREAS the matter was again considered by the Eastern Regional Committee in its 101st meeting held on 06-08, October, 2009 and having taken into consideration all the relevant facts of the case, it was decided to withdraw the recognition of B.P.Ed. course from the next academic session i.e., 2010-2011.
- 6. AND WHEREAS, recognition of the institution viz. **Sunil Dhar Memorial B.P.Ed. College, Vill / PO: Panchthupi, P.S.: Burdwan, Block-Burdwan, Dist: Murshidabad, West Bengal 742161** for the **B.P.Ed. Course** in terms of Section 17(1) of the NCTE Act, 1993 was withdrawn from the academic session i.e., 2010-2011 on the following grounds.
  - (i) Experience certificate of the Principal not submitted by the institution.
  - (ii) Details of part time staff as per NCTE norms not given.
  - (iii) Details of total area and land area not given as per norms. Built up area is less than the requirement. Certified/Notarized coy of the registered land documents along with an affidavit on Rs. 100/- stamp paper duly attested by the Notary regarding land and building not given.
  - (iv) Language learning lab is not available as per the NCTE norms.
  - (v) Library books are less than as per NCTE norms.
  - (vi) Facilities in the Psychology lab inadequate as per NCTE norms.
  - (vii) As per the complaint the institution has submitted the lease deed of same land as submitted by Maa Sarda College of Education (B.Ed.) code No.APE00907.
- 3. AND WHEREAS the Correspondent, Sunil Dhar Memorial B.P.Ed. College, Vill / PO: Panchthupi, P.S.: Burdwan, Block-Burdwan, Dist:Murshidabad, West Bengal 742161 (hereinafter referred to as the applicant), preferred an appeal dated 08.12.2009 to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) under Section 18 of the NCTE Act, 1993 against the said Order.
- 4. AND WHEREAS having considered the verbal submission by the representative of the institution the written representation, the original record of the case and V.T. Report, the Council decided to reverse the order of ERC. Accordingly, the appeal was accepted with direction to ERC to restore recognition to the institution immediately vide Hqrs Order No. F.No.-89-1372/2009-Appeal/A10675, dated 12.02.2010.
