In accordance with the Regulations concerning Norms and Standards for Secondary Teacher Education issued in exercise of the powers conferred under Clause (f) and (g) of sub-section (2) of the Section 32 read with Section 14 and 15 of the NCTE Act 1993 (No. 73 of 1993) institution-wise intake capacity for B.Ed/L.T/Shiksha Shastri Courses was issued for the Session 1997-98. This intake capacity in these courses remain operative unless any order of increase/decrease in intake or de-recognition of the institution is issued under relevant provision of Section 14, 15 or 17 of the NCTE Act 1993. For the convenience sake, an up-to-date consolidated list of all the B.Ed/L.T/Shiksha Shastri institutions of the Northern Region coming under proviso of Section 14(1), and Section 14(3) of NCTE Act 1993 has been reproduced & enclosed with it. The scales mentioned against each institution can not be increased at any level except with the permission of the Northern Regional Committee. Though utmost care has been taken to consolidate the lists issued for 1997-98, even then if there is any discrepancy the latest order issued by NRC in that year about individual institution would prevail. The discrepancy, if any, should be brought to the notice of the undersigned within fifteen days of the receipt of this order.
