- Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
- The institution, if unaided, shall maintain endowment and reserve find as per NCTE norms.

The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year.
