- The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should <u>inter alia</u> give the extent of compliance of the conditions indicated at 1 to 8 above.
- If Shri Shivdan Singh Smriti College, Iglas, Aligarh-202124, (U.P.) contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
