ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Appejay Institute of Education, 1, Industrial Area, Gamma Sector, Surajpur-Kasana Road, Tughlpur, Greater Noida, Gautam Budh Nagar, Uttar Pradesh - 201306 had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for starting B.Ed. of One year from the academic session 2002-2003 with an annual intake of (Not mentioned) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following :-
