**ORDER**

In terms of Section 14(1) of the NCTE Act, 1993 **Astron College of Education, 89-C, Gali No. 1, Thapar Nagar, Meerut, Uttar Pradesh** had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for starting **B.Ed. Course of One year duration** from the academic session **2002-2003** with an annual intake of **120 (One Hundred Twenty)** students.

2. One scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following :-

- (a) The institution has acquired the land for setting up the teacher education institution.
- (b) The institution has made arrangement for conducting the course in rented premises at **89-C, Gali No. 1, Thapar Nagar, Meerut, Uttar Pradesh**
- (c) The institution has created an Endowment Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only) and a Reserve Fund of Rs. 3,00,000.00 (Rupees Three Lacs Only).
- (d) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.

Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Astron College of Education, 89-C, Gali No. 1, Thapar Nagar, Meerut, Uttar Pradesh** for **B.Ed. course of One year duration** from the academic session **2002-2003** with an annual intake of **100 (One Hundred)** students **Subject to fulfillment of the following :-**
