ORDER

Beni Madhav Singh Mahavidyalaya, Madhav Nagar, Bigahiya, Allahabad, Uttar Prodesh had applied to Northern Regional Committee, National Council for Teacher Education for seeking recognition of the B.Ed. course than the academic session 2002-2003 vide letter No. Nil dated 27.12.2001 received on 27.12.2001.

- 1. The institution was inspected on 8.08.2002 by an Expert Committee constituted by this office. The Inspection Report of the Expert Committee, original file of the institution, copy of the NCTF Act, 1993; copy of the Norms and Standards and other relating documents were placed before the NRC, NCTF in its Emergent Meeting held on 26.08.2002.
- 2. After careful perusal of the file, inspection Report and other related documents, the Committee decided that the institution, in light of the provisions contained under Section 14(3)(b) of NCTE Act, 1993, be given an opportunity for making the written representation within one mouth from the date of issue of the letter of the following deficiencies noted in the case.
 - (a) Non availability of sufficient textbooks in the library:
 - (b) Non availability of Journals in the Library.
 - (c) Non existence of Science Laboratory.
 - (d) Non existence of Psychology Laboratory.
 - (e) Non availability of Laboratory Equipment.
 - (f) Non availability of equipment in Educational Technology Laboratory.
- As per the decision of NRC letter No. NRC/NCTE/F-3/LIP-573/7577 dated 11.09.2002 was issued by Northern Regional Committee. National Council for Teacher Education to the institution.
- 5. The institution submitted a written representation vide letter No. Nil dated 20.09,2002. The representation of the institution was placed before the NRC in its 51st meeting to verify the compliance of the deficiencies notified to the institution as mentioned in para 3 above. After careful perusal of the reply and all related documents, the NRC decided second inspection of the concerned institution.
- As per the decision of NRC in the above referred meeting, the second inspection
 was undertaken on 10.10.2002 by an expert committee constituted by this office.
