ORDER

In terms of Section 14(1) of the NCTE Act, 1993. - 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee bereby grants recognition to 1993. Gochar Mahavidyalaya, Rampur Maniharan, Saharanpur, Uttar Pradesh 247451 for B.Ed. one year course from the academic session 2002-2003 with an annual intake of 100 (One hundred) students Subject to fulfillment of the following:-
 - (a) That the institution will ensure that Principal / Head and at least seven faculty members are in position for an intake of 100 (One hundred)students before commencement of the course and a report of this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
