ORDER

In terms of Section 15 (1) of the NUTE Act, 1993. Advance Institute of Management, N11-24, Belli Hapur Bye Pass Road. Adhyatmic Nagar, Ghaziabad, U.P. and submitted in application to the Northern Regional Committee of National Council For Teacher Education for given of recognition for additional 40 seats in B.E.d. Course of One year duration from the academic session 2002-2003.

- One scrut my of the application submitted by the institution, the documents attached therewith and
 the input received from the visiting team, the Committee has noted the following. --
- The institution has acquired the land for setting up the teacher education institution.
- The institution has constructed the building for conducting the course on the above mentioned.
- (iii) The institution has created an Endowment Fund of Rs. 5,00,000.00 (Rupees Five Lacs Oly) and a Reserve Fund of Rs. 3,51,284.00 (Rupees Three Lacs Fifty One Thousand Two Hundred Fighty Four Only).
- The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.
- Now, therefore, in exercise of the powers vested under Section 15 (3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Advance Institute of Management, NH-24, Delhi Hapur Bye Pass Road. Adhyutmic Nager, Ghaziahad, U.P. for increasing 40 seats in B.Ed. course of One year duration from the academic session 2002-2003 from 60 seats to 100 seats Subject to fulfillment of the following:-
- a) That the institution will ensure that Principal / Head and at least Seven faculty members are in position for an intake of 100 (One Hundred) students before commencement of the course and a report to this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- b) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SEXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee.
- c) That the Reserve Fund for an amount equal to three months salary be maintained, in the form of FDR in favour of the management / institution, for a period of not less than <u>SIXTY MONTHS</u> (Five years) to a Nationalized Bank only.
- d) The institution shall comply with the various all other norms and standards as prescribed in the NCTE Regulations.
- Recognition is subject to the condition that the affiliating university shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/UGC/Affiliating University.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
