ORDER

In terms of Section 15(1) of the NCTF Act, 1993 Sudhakar Mahila Mahavidyalaya, S-9/92-93, Khajuri, Nai Basti, Pandey Pur, Varanasi, Uttar Pradesh - 221002 had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for additional 120 (One Hundred Twenty) seats in B.Ed. course of one year duration from the academic session 2002-2003.

- Considering the documents and Order of the Hon'ble High Court dt. 05.09.2002, the Northern Regional Committee in its Meeting held on 13th February, 2003, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, decided to grant recognition to Sudhakar Mahila Mahavidyalaya, S-9/92-93, Khajuri, Nai Basti, Pandey Pur, Varanasi, Uttar Pradesh 221002 for increase in intake from 60 (Sixty) to 100 (One Hundred) scats in B.Ed. course of one year duration from the academic session 2002-2003 subject to fulfillment of the following:-
 - (a) That the institution will ensure that Principal / Head and at least seven-faculty members are in position for an intake of 100 (One Hundred) students before commencement of the course and a report of this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
 - (b) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee.
