ORDER

Institute of Management and Research, 8th Mile Stone, Delhi Meerut Road, Dulta, Ghaziabad 201206, Uttar Pradesh had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B.Ed. course of one year duration (July 2003 to June session 2003-2004) in terms of Section 14(1) of the NCTE Act, 1993.

In scrutiny of the application submitted by the institution, the documents attached therewith and the reports received from the visiting team, the Committee has noted the following:

- (a) The institution has acquired the land for setting up the teacher education institution.
- (b) The institution has constructed the building for conducting the course on the acquired land.
- (c) The institution has created an Endowment Fund of Rs. 1,00,000/- (Rupees One Lakh Only) and a Reserve Fund of Rs. 3,100,000/- (Rupees Three Lakh One Thousand).
- (d) The institution has initiated the process for recruitment of Principals/Head of Department and teachers for the said course.

Therefore, in exercise of the powers vested under Section 14(1) of the NCTE Act, 1993, the Regional Committee hereby **grants recognition** to Institute of Management and Research, 8th Mile Stone, Delhi Meerut Road, Dulta, Ghaziabad - 201206, Uttar Pradesh for an intake of 100 seats (One Hundred) seats in B.Ed. course of one year duration with effect from the academic session 2003-2004 subject to fulfillment of the following before the commencement of the session:

- (a) Appointment of the faculty members duly qualified and suitably per the norms of NCTE/SAC/UGC is to be completed before the commencement of the session.
- (b) The countersigned statement of all faculty members from the Register of the concerned University should be submitted before the commencement of the academic session 2003-2004.
- (c) The institution shall adhere to all the other Regulations and Guidelines as framed by NCTE from time to time.
- (d) The institution shall **within ONE MONTH** of the receipt of recognition order convert its Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank and (and not any certificate) to be operated along with an official of the Regional Committee.
- (e) That the Reserve Fund for an amount equal to Sixty months salary of the Teachers (Rs. 3,60,000/-) maintained in the form of FDR in favour of the Management Institution for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank.
- (f) Non-compliance of above conditions as mentioned under this Order of Recognition shall invite action under Section 17(1) of NCTE Act, 1993.
