ORDER

Dayanand Vaidik Post Graduate College, Orai, Distt. - Jalaun-285001, Uttar Pradesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for starting M.Ed. course of one year duration as an existing institution.

- The application was referred to the Council for its consideration as per the Regulations dated 27.09.2001. The Council in its 17th meeting held on 29th July 2005 has approved the case for treating as an existing institution vide letter no. 48-3/2004/NCTE/N&S dated 11" August 2005
- Now, therefore, in exercise of the powers yested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Dayanand Vaidik Post Graduate College, Orai, Distt. - Jalaun-285001, Uttar Pradesh for an annual Intake of 25 seats (Twenty five only) in M.Ed. course of One year duration with effect from 11 August 2005 subject to fulfillment of the following before the commencement of the session.
 - Appointment of the faculty members duly qualified and staff as per the norms of (a) NCTE/State Govt./ UGC is to be completed before the commencement of the
 - The countersigned statement of all faculty members from the Registrar of the (b) concerned University should be submitted before the commencement of the academic session.
 - The institution shall adhere to all the other Regulations and Guidelines as framed (c) by NCTE from time to time.
 - The institution shall within DNF MONTH of the receipt of recognition order, (d) convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee.
 - That the Reserve Fund for an amount equal to three months salary of the (e) teachers & staff be maintained, in the form of FDR in favor of the management / institution, for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank.
 - Non-compliance of above conditions as mentioned vide this Order of Recognition (f): shall invite action under Section 17(1) of NCTE Act, 1993.
- 4. The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appeinted required number of faculty members (including Principal / Head of Department), as per the norms of the NCLE / UGC / Affiliating University.
- 5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory budies like UGC and State Government, etc.
