ORDER

Rama Devi Kanya mahavidyalaya, E-3, Sector-61, Noida, Gautom Budha Nagar, Uttar Prodesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for BTC of Two Year duration in terms of section 15(1) of NCTE Act, 1993.

- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Roma Devi Kanya mahavidyalaya, E-3, Sector-61, Noida, Gautam Budha Nagar, Uttar Pradesh for an annual intake of 50 seats (Fifty Only) (50 seats in the 1st year and the same for the II'd year in BTC course of Two year duration with effect from 11 August 2005 subject to compliance of the following before the commencement of the academic session.
- Appointment of the faculty members duly qualified and stuff as per the norms of NCIE/ State (a) Govt /SCFRT is to be completed before the commencement of the session.
- The countersigned statement of all faculty members from the Director, SCERT should be submitted (b) before the commencement of the academic session.
- The institution shall adhere to all the other regulations and guidelines as fromed by NCTE from time to (c) time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund (d) account into a Joint Account in the form of FDR for a period of not licis than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount equal to three months solvry of the Teachers & Staff be created (e) within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
- Before starting the course the institution should stack prior parmission of the competent authority for (1) conducting the exams and approval of the curriculum that they are going to adopt for the course.
- Institutions if starts the training programme without prior approval/permission of competent (g) outhority/examining body regarding the curriculum they have adopted and conduct of examination for award of Diploma/Certificate the recognition of such institutions shall be withdrawn.
- Non-compliance of the above mentioned conditions shall couse action under section 17 (1) of NCTE Act. (h):
- The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt / Affiliating body
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like SCERT/ State Government, etc.
