 - The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - That the Reserve fund for an amount equal to three months salary of the Teacher & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/ institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank

Non-compliance of the above mentioned conditions shall cause action under Section 17(1) of NCTL Act, 1993

- The recognition is subject to the condition that the affiliating University shall 3. ensure that, among other things, the institution has appointed required number of faculty members (including Principal/ Head of Department), as per the norms of the NCTE / UGC / Affiliating University.
- Further, the recognition is subject to fulfillment of all such other requirements as 4_ may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at 5. the end of each academic year along with a copy of the approval of the affiliating
