WHEREAS, the present institution, namely, Gautam Budha Degree College, Sahiyapur-Majhila, Kannauj, Uttar Prodesh-209723 hoving Managing Society 'Adarsh Shiksha Samiti, Sahiyapur had made earlier application for recognition to start 8. Ed. programme from academic session 2003-2004. As required by the NCTE Regulations 2002, towards Endowment Fund, the institution had submitted five Fixed Deposit Receipts issued by Farrukhabad Gramin Bank, Branch-Agaus, Meharpura, which on scrutiny and verification were found having been altered from Rs. 50,000/- to Rs. 5,00,000/-. The Chairman, Farrukhabad Gramin Bank, Fatehpur vide his letter dated 15.04.2004 also confirmed that total amount of Fixed Deposit Receipts was Rs. 50,000/- and not Rs. 5,00,000/-. After disclosure of this forgery/alteration in valuable documents the NRC in its 88<sup>th</sup> meeting after service of Show Cause Notice and being satisfied of the forgery/alteration decided to reject the said application and consequently vide formal order No. F. NRC/NCTE/F-3/UP-674/462-470 dated 13/19.04.2005, the above application of the institution was rejected.

- AND WHEREAS, the same Institution and Managing Society vide covering letter dated 31.12.2004 has made present application for recognition to start B. P. Ed. programme from academic session 2005-2006.
- AND WHEREAS, the NRC in its 90<sup>th</sup> meeting has taken a general decision regarding new
  applications received such institutions/ societies whose applications submitted in previous years
  could not be granted due to submissions of fraudulent documents be not considered.
- AND THEREFORE, in terms of above decision of NRC, the above application, seeking recognition to start 8, P. Ed. course is hereby refused.
- 5. Consequently, the institution shall not admit any student in B. P. Ed course and the examining body shall neither grant affiliation to the institution nor hold examination, whether provisional or otherwise for the B. P. Ed course if conducted by the said institution unless the institution is granted permission for the said course by the NRC/NCTE.
- 6. In accordance with section 17 (4) of the NCTE Act, 1993, the qualification in teacher education, namely B. P. Ed. obtained pursuant to such course or training in the above institution shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other educational body aided by the Central Government or any State Government.
