- 2. The institution was inspected on 09.08.2002 by an Expert Committee constituted by this office. The Inspection Report of the Expert Committee, original file of the institution, copy of the NCTE Act, 1993, copy of the Norms and Standards and other relating documents were placed before the NRC in its Emergency Meeting held on 26.08.2002.
- 3. After careful perusal of the file, Inspection Report and other related documents, the Committee decided that the institution, in light of the provisions contained under Section 14(3)(b) of NCTF. Act, 1993, he given an opportunity for making the written representation within one month from the date of issue of the letter of the following deficiencies noted in the case.
 - (a) Non availability of class rooms.
 - (b) Non availability of Separate Building.
 - (c) Non availability of Library.
 - (d) Non availability of text books.
 - (e) Non availability of Journals.
 - (2) Non existence of Educational Technology Laboratory.
 - (g) Non existence of Science Laboratory.
 - (h) Non existence of Psychology laboratory,
 - (i) Non availability of Endowment Fund.
 - (j) Non availability of Reserve Fund.
- 4. As per the decision of NRC, a letter No. NRC/NCTE/F-3/UP-595/2000/7625 dated 13 September, 2002 was issued by Northern Regional Committee, National Council for Teacher Education to the institution communicating deficiencies and giving an opportunity to make written representation within one months of date of issue of letter before refusing recognition of the proposed course an account of deficiencies noted above.
