## ORDER

Sir M.U. Teacher Training College, Near Mandi Samiti, G.T.Road, Etch, Uttar Pradesh -207001 submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for 8.Ed. course of one Year duration in terms of section 14(1) of NCTF Act, 1993.

- New, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCIE Act, 1993, the Regional Committee hereby grants recognition to Sir M.U. Teacher Training Collage, Near Mondi Samiti, G.T. Road, Etah, Uttar Pradesh - 207001 for an annual intake of 100 seats (One Hundred only) in B.Ed. course of One year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session.
  - a. Appaintment of the faculty members duly qualified and staff as per the norms of NGTE/ State Govt JUGC is to be completed before the commencement of the session.
  - b. The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the numericement of the academic session 2004-2005.
  - c. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time
  - d. The institution shall within one month of the receipt all Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 50 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
  - e. That the Reserve Fund for an amount equal to three months solary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in levour of the management/institution, for a period of not less than sixty menths (Five years) in a Nationalized Bank
  - f. Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NOTE Act, 1993.
- The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / WAS / Affiliating University.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory badies like UGC and State Government, etc.
- The institution shall subject to the Regional Committee a Self-Approxal Report at the end of each academic year along with a copy of the approval of the offiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant
