The institution shall adhere to all the other Regulations and Guidelines as framed by (c) NCTE from time to time

The institution shall within ONE MONTH of the receipt of recognition order, (d) convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with up official of the Regional

That the Reserve Fund for an amount equal to three months salary of the teachers & (e) staff be maintained, in the form of FDR in favor of the management / institution, for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank.

Non-compliance of above conditions as mentioned vide this Order of Recognition (1) shall invite action under Section 17(1) of NCTE Act, 1993.

The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
