ORDER

Shri Parshvanath Institute of Education & Research, 18th Kms. Stone, Mecrut Delhi Road, Mohiuddinpur, Mecrut - 250205, Uttar Prodesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B.T.C. of Two Year duration in terms of section 15(1) of NCTE Act, 1993.

- 2. Now, therefore, in exercise of the powers visited under Section 15(3)(a) of the NCTE Act, 1993, this Regional Committee hereby grants recognition to Shri Parshvanath Institute of Education & Research, 18th Kms. Stane, Meerut Delhi Road, Mohiuddinpur, Meerut 250205, Uttar Prodesh for an annual intake of 50 seats. (Fifty Only) (50 seats in the 1st year and the same for the II^{nt} year in BTC course of Two year duration with affect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session.
 - (a) Appaintment of the faculty members duly qualified and staff as per the norms of NCTE/ State. Sout/SCERT is to be completed before the commencement of the session.
 - (b) The countersigned statement of all faculty members from the Director. SCERT should be submitted before the commencement of the academic session 2004-2005.
 - (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - (e) That the Reserve Fund for an amount equal to three months solarly of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
 - 60 Before Starting the course the institution should seek prior permission of the competent authority for conducting the exams and approved of the curriculum that they are going to adopt for the course.
 - (g) Institutions if starts the training programme without prior approval/permission of competent authority/examining body regarding. The corriculum they have adopted and conduct of examination for award of Diploma/Cartificate the recognition of such institutions shall stand withdrawn.
 - (h) Non-compliance of the above mentioned conditions shall sause action under section 17 (1) of NCTE Act, 1993.
- 3. The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt. / Affiliating body.
