ORDER

Inderpresthe Engineering College, 63; Site-IV, Surya Nagar Flyover Road, Schibabad Industrial Area, Ghaziabed (UP) 201 010 submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for NTT course of two Year duration in terms of section 15(1) of NCTE Act, 1993.

- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Inderpression Engineering Callege, 63, Site-IV. Surya Nagar Flyover Road, Sahibabad Industrial Area, Ghaziabad (UP) 201 010 for an annual Intake of 50 (Fifty seats only) with an annual intake of 50 in the 1" year and the same for the 2" year in NTT course of two year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session.
 - Appointment of the faculty members duly qualified and staff as per the norms of (a) NCTE/State Govt / concerned body is to be completed before the commencement of the session.
 - The countersigned statement of all faculty members from the Director, SCERT should be (b) submitted before the commencement of the academic session 2004-2005.
 - (c) The institution shall adhere to all the other Regulations and Guidelines as framed by NCTE from time to time.
 - (4) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee.
 - (e) That the Reserve Fund for an amount equal to three months solary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
 - Non-compliance of above conditions as mentioned vide this Order of Recognition shall **(f)** invite action under Section 17(1) of NCTE Act, 1993.
- 3 The Recognition is subject to the condition that the affiliating body shall ensure that, among ather things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NOTE / State Govt. / Affiliating body (SCERT).
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed. by other regulatory bodies like SCERT and State Sovernment, etc.
