ORDER

Forte Institute of Technology, Faculty of Education, Green Park, Kaseru Buxar, Mawana Road, Meerut, Uttar Pradesh submitted on application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for 8.P.Ed-course of one Year duration in terms of section 15(1) of NCTE Act, 1993.

- 2. Now, therefore in exercise of the powers vested under Section 15(3)(b) of the NCTE Act, 1993, the Regional Committee hereby grant recognition to Forte Institute of Technology. Faculty of Education, Green Park, Kaseru Buxar, Mawana Road, Meerut, Uttor Prodesh for an annual intake of 50 seats (Fifty only) in B.P.Ed. course of One year duration with effect from the academic session 2004-2005 subject to Julfillment of the following before the commencement of the session.
- (a) Appaintment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt /UGC is to be completed before the commencement of the session.
- (b) The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2004-2005.
- (c) The institution shall adhere to all the other regulations and guidelines as framed by NGTE from time to time.
- (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- (e) That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
- (f) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- 3. The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Hend of Department), as per the norms of the NCTE / UGC / Affiliating University.

- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Approisal Report at the and of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of the above conditions or any of the pravisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
