ORDER

Sant Bula Setyonam Des Virbal Mahovidyalaya, Village-Amori, Post-Dallahapur, Disti-Ghazipur (UP) 275-202 submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for BTC of Two Year duration in terms of section 15(1) of NCTE Act, 1993.

- 2. Now, therefore in exercise of the powers vested under Section 15(3)(a) of the NCTE Act. 1993, the Regional Committee hereby grants recognition to Sent Bula Setyanom Dos Virbal Mahavidyaleya. Village-Amari. Post-Dullahopur. Distt-Shazipur (UP) 275-202 for an arrurul intoine of 50 seats. (Fifty Only) (50 seats in the 1th year and the same for the Lith year in BTC course of two year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the communication of the session.
 - (a) Appointment of the faculty members duly qualified and staff as per the norms of MCTE/ State.
 Gov. ASCERT is to be completed before the commencement of the session.
 - (b) The countersigned statement of all faculty mambers from the Director, SCERT should be submitted before the commencement of the academic session 2004-2005.
 - (c) The institution shall adhere to all the other regulations and guidelines as framed by NCIE from time to time.
 - (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an of ficial of the Regional Committee.
 - (e) That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
 - (f) Before Storting the course the institution should seek prior permission of the competent authority for conducting the exams and approved of the corridalism that they are going to adopt for the course.
 - (q) Institutions if starts the training programme without prior approval/permission of competent authority/examining body regarding the curriculum they have adopted and conduct of examination for pward of Diploma/Certificate the recognition of such institutions shall stand withdrawn.
 - (h) Non-compliance of the above mentioned conditions shall cover action under section 17 (1) of NETE Act, 1993.
- The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt / Affiliating loody.

- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like SCERT/ State Government, etc.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each anademic year along with a capy of the approval of the affiliating body / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Charleved Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE. Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
