## ORDER

District Institute of Education & Training, (DIET), Chambe at Saru Distt. - Chambe, Himachal Pradesh - 176310 submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of additional seats in J.B.T. Course of two Year duration in terms of section 15(1) of NCTE Act. 1993.

- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act. 1993, the Regional Committee hereby grants recognition to District Institute of Education & Training. (DIET), Chamba at Saru, Distt. Chamba, Himachal Prodesh 176310 for an additional intake of 100 (One Hundred) seats thereby making the total annual intake of the institution to 200 (Two Hundred) i.e. 200 in the 1° year and the same for the 2<sup>nd</sup> year in J.B.T. Course of two year duration with effect from the academic session 2004-2005 subject to fulfillment of the tallowing before the commencement of the session:
  - a. Appointment of the faculty members duly qualified and staff as per the norms of NGTE/ State Govt./USC is to be completed before the commencement of the session.
  - b. The countersigned statement of all faculty members from the birector. SCERT should be submitted before the commencement of the academic session 2004-2005.
  - c. The institution shall adhere to all the other regulations and guidelines as framed by NATE from time to time.
  - d. Before starting the course the institution should seek prior permission of the competent authority for conducting the exems and approval of the curriculum that they are going to adopt for the course.
  - e. Institution if starts the training programme without prior approval / permission of competent authority / examining body regarding the curriculum they have adopted and conduct of examination for award of Diploma / Certificate the recognition of such institutions shall withdrawn.
  - Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NOVE Act, 1993.
- 3. The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / Affiliating body.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, 5CERT, etc.
