- That the Reserve Fund for an amount equal to three months solary of the Teachers & (e) Staff be greated within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Book
- Non-compliance of the above mentioned conditions shall crosse action under section 17 (1) (f) of NCTE Act, 1993.
- The Recognition is subject to the condition that the offiliating University shall writine that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.

- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like USC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Approisal Reput of the end of each academic year along with a cupy of the approval of the affiliating University / State Smeaternie of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Churtered Accountant
