ORDER

- (c) The institution shall arihere to all the other regulations and gradelines as framed by NCTE from time to time.
- (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- (e) That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in Layour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bunk.
- (f) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- The Recognition is subject to the condition that the affiliating University shall ensure
 that, among other things, the institution has appointed required number of faculty members
 (including Principal / Head of Department), as per the norms of the NCTE / USC / Affiliating
 University.
