ORDER

R.N. Institute of Modern Management Education & Research Centre, 1. Rambogh Colony (Near Shastri Nagar Sector 4), Meanut - 250002, U.P. submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for BTC of Two Year duration in terms of Section 15(1) of NCTE Act, 1993.

- 2. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to R.N. Institute of Modern Management Education & Research Centre, 1, Rombogh Colony (Near Shastri Nagar Sector -4), Meerut 250002, U.P. for an annual intoke of 50 seats. (Fifty Only) (50 seats in the 1st year and the same for the IIIth year in 8TC course of two year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session.
 - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Gayl./SCERT is to be completed before the commencement of the session.
 - (b) The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commoncement of the academic session 2004-2005
 - (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Conventee.
 - (e) That the Reserve Fund for an amount equal to three months solarly of the Teachers & Staff be created within one munth from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
 - (f) Before starting the course the institution should suck prior permission of the competent authority for conducting the exams and approved of the autriculum that they are going to adopt for the course.
 - (g) Institutions if starts the training programme without prior approval/permission of competent authority/examining body regarding—the curriculum they have adapted and conduct of examination for award of Diploma/Certificate the recognition of such institutions shall stand withdrawn.
 - (h) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- 3. The Recognition is subject to the condition that the uffiliating body shall ensure that, among other things, the institution has appointed required number of faculty members [including Principal / Head of Department), as per the norms of the NCVE / State Govt. / Affiliating body
