ORDER

R.N. Institute of Modern Management Education & Research Centre, 1, Rambagh Colony (Near Ghadri Nagar Sector -4), Meerut - 250002, U.P., submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for BTC of Two year duration in terms of section 15(1) of NCTE Act, 1993.

Now therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to R.N. Institute of Modern Management Education & Research Centre, 1, Rambagh Colony (Near Ghadri Nagar Sector -4), Meerut - 250002, U.P. for running Afilia of 50 seats (Fifty Only) (50 seats in the 1st year and the same for the 2nd year) in BTC course of Two year duration with effect from the academic session 2004-2005 subject to run from the following before the commencement of the session.

1. Registration of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./AFCER, is to be completed before the commencement of the session.
2. The sworn/signed statement of all Faculty members from the Director, SCERT should be submitted before the commencement of the academic session 2004-2005.
3. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
4. The institution shall within six months of the receipt of Recognition order, convert the Endowment Fund account into Joint account in the form of FDR for a period of not less than 60 months (Five years) in Nationalized bank only to be operated along with an officer of the Regional Committee.
5. The Reserve Fund for an amount equal to three months salary of the Teachers & Staff be opened in this bank forth from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in Nationalized bank.
6. From starting the course, the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum that they are going to adopt for the course.
7. Institution if starts the training programme without or an approval/permission of competent authority/recognising body regarding the curriculum they have adopted and conduct of examination in excess of the one/one half date, the recognitions of such institutions shall stand withdrawn.
8. Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.

The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (excluding Principal / Head of institution) as per the norms of the NCTE / State Govt. / Affiliating body.
