## ORDER

V- Tech Institute of Integrated Technology, Opp. Chaker Park, S.T. Road, Bulandshahar, Uttar Fradesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grunt of recognition for Nursery Teacher Education programme of Two Year duration in terms of section 15(1) of NCTE Act, 1993.

- 2. Now therefore, in exercise of the powers vested under Section 10(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to V. Tech. Institute of Integrated Technology. Opp. Chokor Park. 6.T. Road, Bulandshahar, Uttar Prodesh for an annual intake of 50 seats. (Fifty Only) (50 seats in the 1" year and the same for the II" year in NTT course of two year duration with effect from September 15, 2004 subject to compliance of the following conditions before the commencement of the academic session.
  - (n) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt/SCERT is to be completed before the commencement of the session.
  - (b) The countersigned statement of all foculty members from the Director. SCERT should be submitted before the commencement of the academic session.
  - (c) The institution shall ashere to all the other regulations and guidelines as framed by NCTE from time to time.
  - (d) The institution shall within one month of the recoupt of Recognition order, convert the Endowment Fund occaunt into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated slong with an official of the Regional Committee.
  - (a) That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and munitained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
  - (f) Nun-cumpliance of the above mentioned conditions shall course action under section 17 (1) of NGTE Act, 1993.
- The Recognition is subject to the condition that the affiliating body shall ensure that among other things, the institution has appointed required number of faculty members (including Principal / Flead of Department), as per the norms of the NCTE / State Sout / Affiliating body.
