ORDER

Smt. Rama Devi Mahila Mahavidyalaya, Jhinjhak, Distt. - Kanpur Dehat-209302, Uttar Prodesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for Elementary Teacher Education Programme of Two Year duration in terms of section 15(1) of NOTE Act, 1993.

- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Smt. Roma Devi Mohila Mahavidyalaya, Thinjhak, Distt. Kanpur Dehat-209302, Uttar Prodesh for an annual intake of 50 seats (Fifty Only) (50 seats in the 1st year and the same for the IIst year in BTC course of Two year duration with effect from September 15, 2004 subject to compliance of the following conditions before the commencement of the academic session.
 - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./SCERT is to be completed before the commencement of the session.
 - (b) The countersigned statement of all foculty members from the Director, SCERT should be submitted before the commencement of the acodemic session.
 - (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FOR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an afficial of the Regional Committee.
 - (e) That the Reserve Fund for an amount equal to three months valory of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
 - (f) Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approved of the corriculum that they are going to adopt for the course.
 - (g) Institutions if starts the training programme without prior approval/permission of competent authority/examining body regarding. The curriculum they have adopted and conduct of examination for award of Diploma/Certificate the recognition of such institutions shall be withdrawn.
 - (h) Nurrecompliance of the oblave mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993
- 3 The Recognition is subject to the condition that the attillating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the harms of the NCTE / State Govt. / Affiliating body.
