## ORDER

Dau Dayal Mahila (P.G.) College, Bye Pass Road, Firozabad-283203 (U.P.) submitted an application to the Northern Regional Committee of National Connoil for Tencher Education for grant of recognition for <u>BTC course</u> of two Year duration from the academic <u>session 2004-2005</u> with an annual intake of 200 (Two Hundred) students in terms of section 15(1) of NCTE Act, 1993.

- 2. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Dau Dayal Mahila (P.G.) College, Bye Pass Road, Firozabad-283203 (U.P.) for an annual intake of 50 (Fifty seats only) with an annual intake of 50 in the 1<sup>st</sup> year and the same for the 2<sup>th</sup> year in <u>BTC course</u> of two year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session.
  - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/State Govt./ concerned body is to be completed before the commencement of the session.
  - (b) The countersigned statement of all faculty members from the Registrar of the concerned body should be submitted before the commencement of the academic session 2004-2005.
  - (c) The institution shall adhere to all the other Regulations and Guidelines as framed by NCTE from time to time.
  - (d) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other cortificate) to be operated along with an official of the Regional Committee.
  - (e) That the Reserve Fund for an amount equal to three months salary of the teachers & staff be maintained, in the form of FDR in favor of the management / institution, for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank.
  - (f) Non-compliance of above conditions as mentioned vide this Order of Recognition shall invite action under Section 17(1) of NUTE Act, 1993.
- 3. The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Concerned Affiliating Redy.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like concerned body and State Government, etc.
