Beacon Institute of Technology, Partapur Bye Pass Road, Meerut - 250103, U.P. submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B.Ed. course of One Year duration with an additional 40 (Forty) students in terms of section 15(1) of NCTE Act, 1993.

This is in continuation of this office order No. NRC/NCTE/F-3/UP-802/2003/8169-8177 dated 24/1/2004/ whereby the institution has been granted recognition from the session 2004-2005 with an additional intake of 40(Forty) Total (60+40=100) seats in B.Ed. course of one-year duration with effect from the academic session 2004-2005.

The matter was again considered by the Northern Regional Committee on the representation of the institution regarding reconsideration of the order for the year 2003-2004 instead of 2004-2005 and decided that the recognition to the institution be granted from the academic session 2003-2004 subject to the condition that the academic session of the concerned University will not be disturbed by any means.
