ORDER

Mahaveer Institute of Technology, Main Shardhana Road, Post - Dawstwa, Tchsil -Shardhana, Distt. - Meerut (U.P.) submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for BTC course of two Year duration in terms of section 14(1) of NCTE Act, 1993.

Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993. the Regional Committee hereby grants recognition to Mahaveer Institute of Technology, Main Shardhann Road, Post - Dawatwa, Tchsil - Shardhana, Distt. - Meerut (U.P.) for au annual intake of 50 seats (fifty only) (with an annual intake of 50 1st year and, the same for the 2st year) in BTC course of two year duration with effect from the academic session 2005 subject to fulfillment of the following before the communement of the session.

Appointment of the faculty members duly qualified and staff as per the norms of (a) NCTE/State Govt./ concerned body is to be completed before the commencement of the session.

The countersigned statement of all faculty members from the Registrar of the (6) concerned body should be submitted before the commencement of the scademic session 2004-2005

The institution shall adhere to all the other Regulations and Guidelines as framed by (c) NCTE from time to time.

The institution shall within ONE MONTH of the receipt of recognition order, (d) convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee

That the Reserve Fund for an amount equal to three months salary of the teachers & (e) staff be maintained, in the form of FDR in favor of the management / institution, for a period of aut less than SIXTY MONTHS (Five years) in a Nationalized Bank. (I)

Non-compliance of above conditions as mentioned vide this Order of Recognition shall invite action under Section 17(1) of NCTE Act, 1993.

3. The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating body.
