ORDER

Mahaveer Institute of Management & Technology, Dehradun Road, Village - Rsulpur, Post - Chhutmalpur, Distt - Sharanpur (U.P.) submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for <u>B.Ed</u>, course of one Year duration in terms of section 14(1) of NCTE Act, 1993.

- 2. Now, therefore, in exercise of the powers vested under Section 14(2)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Muhaveer Institute of Management & Technology, Dehradun Road, Village Raulpur, Post Chhutmalpur, Distt Sharanpur (U.P.) for an annual intake of 100 scats (One Hundred only) in _B.Ed. course of One year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session.
 - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/State Govt./ UGC is to be completed before the commencement of the session.
 - (b) The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2004-2005.
 - session 2004-2005.

 (c) The institution shall adhere to all the other Regulations and Cuidelines as framed by NCTE from time to time.
 - (d) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee.
 - (e) That the Reserve Fund for an amount equal to three months salary of the teachers & staff be maintained, in the form of FDR in favor of the management / institution, for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank.
 - (f) Non-compliance of above conditions as mentioned vide this Order of Recognition shall invite action under Section 17(1) of NCTE Act, 1993.
- 3. The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
