ORDER

WHEREAS, the Institution, namely, **S. R. College of Education, 35, Shivaji Road, Meerut (UP) - 250001** has made an application to Northern Regional Committee (in short NRC) under section 14 (1) of NCTE Act, 1993 to seek permission to start new course of B.P.Ed. Course from academic session 2002-2003 vide covering letter dated nil and the same was received in the office of NRC on 28.12.2001.

2. The institution was inspected on **27.10.2004** by an inspection team of expert constituted by NRC. The inspection team noted certain deficiencies in its report submitted and the same was considered by NRC in its 85th meeting held on 04th-05th November, 2004.

3. After careful perusal of the file, inspection Report of the experts and other related documents, the committee in the above meeting being satisfied that the institution did not fulfill the requirements laid down in sub-clause (a) of section 14 (3) of NCTE Act, 1993 decided that the Institution be given a reasonable opportunity for making representation or drawing its attention with following deficiencies existed vis-à-vis NCTE Norms:

- **Physical resources not available at all.**
- **Library facilities are not created.**
- **Only 250 books have been added for the B.P.Ed. Programme, which is not sufficient for running the programme effectively.**
- **Encyclopedia not provided in the library.**
- **Playground is not provided.**
- **Provision for Principal Room, Faculty Room, Office Room and Store Room not available.**

Consequently as per above decision, letter no. F.NRC/NCTE/F-3/UP-612/2004/10549 dated 10.11.2004 was issued communicating the above deficiencies to the Institution with an opportunity to make representation within one month before passing an order refusing permission to the new course of B.P.Ed.

4. The Institution has not submitted any reply to the said notice. The matter was placed in 97th meeting of NRC held on 27th - 28th October 2005, wherein after careful consideration of all aspects, the Northern Regional Committee decided that the Institution has not complied with the deficiencies pointed out in the Notice and hence, decided to reject the application and close the file of the Institution.

5. AND THEREFORE, in terms of above decision of NRC, the application of **S. R. College of Education, 35, Shivaji Road, Meerut (UP) - 250001** seeking permission for the new course of B.P.Ed. is refused under Section 14(3)(b) of the NCTE Act, 1993.

6. Consequently, the Institution shall not admit any student in B.P.Ed. Course and other concerned body(s) shall not hold examination, whether provisional or otherwise for the B.P.Ed. Course if conducted by the said Institution unless the Institution is granted permission for the said course by the NRC / NCTE.

7. In accordance with section 17(4) of the NCTE Act, 1993 the qualification in teacher education, namely B.P.Ed., obtained pursuant to such course or training in the above institution shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

8. Further, if the institution is not satisfied by the order, it can prefer an appeal before National Council for Teacher Education, Hans Bhawan, Wing II, 1, Bahadur Shah Zafar Marg (Near ITO), New Delhi - 110 002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the date of Issue of this order. The guidelines for appeal are enclosed herewith.
