WITEREAS Lokmanya Tilak Teachers Cullege, Dabok, Udaipur, Rajasthan bad applied to Northern Regional Committee, National Council for Teacher education for seeking recognition of BA, B.E.d. four year course from the academic session 2004-2005. The application was received in NRC Office on 21.06,2004.

- WHEREAS, the institution was issued a letter communicating deficiencies dt. 20.08/2004 with the condition to submit the following documents :-
 - The application submitted after the prescribed last date.
 - (h) Original Fixed Deposit Receipt of RS, 5.00 lakhs towards Endowment Fund - The institution did not submit the FDR.
 - (0) No Objection Certificate in original issued by the State Government - No Objection Certificate has not been submitted by the institution.
 - Eand Title Certificate issued by a local practicing lawyer The institution did not submit (d) the Land Title Certificate.
 - Sworn Affidavit verifying the contents given in the application form and the documents (c) attrached therewith duly affested through a First Class Migistrate / SDM / ADM - The institution did not submit the Sworn Affidavit.
 - (0) Undertaking on non-judicial stamp paper duly attested by the Notary The undertaking submitted by the institution is signed by Prof. M.S. Trivedi, Registrar, Janardhan Rui. Nagar Rajasthan Vidyapoeth (Deserted University), Udaipur, This requires a clariffication from the institution whether the Registrar, Janardhan Rai Nagur Rajasthan Vidyapeeth (Deemed University) is authorized functionary of the institution to submit the Undertaking or not.
 - (9) Legally land documents. Photocopy of a copy of Kratani is submitted by the institution. the copy is very faint and not properly readable. Further from this document it appears that land mentioned therein are in the name / khatedan of Shoee Vidyaqueeth, Rajashan, Edaipur at Dabok but the name of the managing society is Rajushan Vidyapeeta, Primi facie "Shree Vidyapeeth, Rujushan, Uduipuna Dabok" and "Rajusthan Vidyapeethi" appears to be one and the same institution but it requires clarification by proper document / Affidavil / Certificate from a competent authority. Hence, for a proper compliance the institution is required to submit following documents :
 - a. Original Certified copy of revenue record (Khatoni etc.) showing to the land to be in the name / khatedari of the institution or its managing society.
 - b. Proof / document as pointed out above that the managing society of the institution. immely. Rajasthan Vidyapeeth, Udaipur and "Shree Vidyapeeth, Rajasthan, or Dabok" are one and the same institution to certify that the land stands in the Khatedari / name of managine society / institution.
 - c. The Undertaking is submitted by the Registrar, Janardhan Rai Nagar, Rajasihan Vidyapeeth, Udaipur requiring clarification about the mininging society of the institution.
 - (h) Copy of the building plan approved by the competent authority - Computerized copies of drawings of various buildings, including college building plan of Janardhan Rar Nagar, Ragasthan Vidyapeeth are submitted. However these plans are not approved a sanctioned from any local authority. It also requires clarification as to how the college holdering fulls in awnership of either the institution or the managing society. In case no approval samilian from any local authority is required for the construction of it building(s) being in rural area, then proof of the same be submitted, which may be by way of an Affidavii and a certificate of the concerned Com Panchyar to this effect.

- 4. AND WHERLAS, as per the decision of NRC taken in its 88th meeting a Show Cause Notice was issued to the institution on the following deficiencies of essential deficiencies:-

(a) The application submitted after the prescribed last date.

- (b) Original Fixed Deposit Receipt of RS, 5.00 lakhs towards Endowment Fund. The institution did not submit the FDR.
- (c) No Objection Certificate in original issued by the State Government No Objection Certificate has not been submitted by the institution
- (d) Land Title Certificate issued by a local practicing lawyer The institution did not submit the Land Title Certificate.
- (c) Sworn Affidavit verifying the contents given in the application form and the documents attached therewith thily attested through a First Class Magistrate / SDM / ADM | The instantion did not submit the Sworn Affidavit.
- Ondertaking on non judicial stamp paper duly attested by the Notary The indertaking submitted by the institution is signed by Prof. M.S. Trivedi, Registrar, Janardhan Rui Nagar Rajasthan Vidyapceth (Decined University), Udappar, This requires a chaiffication from the institution whether the Registrar, Janardhan Rol Nagar Rajasthan Vidyapceth (Decined University) is authorized functionary of the institution to submit the University or not.
- Legally land documents Photocopy of a copy of Knatoni is submitted by the institution, the copy is very faint and not properly readable. Further from this document it appears that land mentioned therein are in the name / klustedari of Shree Vidyapeeth. Rajashan.
