## ORDER

WHEREAS, vide covering letter dated December 30, 2003, the Institution, namely, Tika Ram Girls College, Sonopat, Harvana - 131001 has made application to Northern Regional Committee (in short NRC), Jaipur seeking permission to start new course of B.P.Ld. with an annual intake of 50 students (One Unit) from academic session 2004-2005. However, the NRC in its 90th meeting held on 22nd and 23th April, 2005 decided to refuse the application / permission for the reasons mentioned in the order dated 04th June, 2005 communicated by the office to the institution in pursuance to the said decision.

- 2. AND WHEREAS, the aforesaid order having been reversed by the Appellate Authority, NCTE-New Dolli vide its order dated 28th September, 2005 in an appeal preferred by the institution under section 18 of the NCTE Act, 1993, the NRC in its 9718 meeting held on 27" and 28" October, 2005 has decided to implement the aforesaid decision of the NCTE.
- NOW THEREFORE, in exercise of the powers vested under Section 13 (3) (a) of the NCTF Act, 1993, the Northern Regional Committee hereby grants permission to Tika Ram Girls College, Sonepat, Haryana - 131001 for B.P.Ed. course of on year duration w.e.f. 28th October, 2005 with an annual intake of 50 (Fifty) students subject to fulfillment of the following:-
  - Appointment of the faculty members duly qualified and staff as per the norms of NCTE/State Govt./UGC is to be completed before commencement of the session.
  - The countersigned statement of all faculty members from the (b) university should be submitted before the concerned commencement of the academic session.
  - The institution shall adhere to all other regulations and guidelines as framed by NCTL from time to time.
  - (d) The institution shall within one month of the receipt of this order, convert the Endowment Fund account into a joint Account in the form of FDR for a puriod of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
  - That the Reserve fund for an amount of equal to three months. salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than 60 months (Five Years) in a Nationalized Bank,

- (f) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- 4. The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/concerned University/Affiliating Body.
- 5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- 6. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17 (1) of the NCTE Act.
