#### ORDER

1 5 DEC 2005

WHEREAS, the Society, namely, "Adarsh Shiksha Samiti, Sahiyapur-Majhila (Kannauj)", registered under Societies Registration Act, 1860, having Shri Ram Sanehi S/o Shri Ram Swroop as its Manager, in terms of its resolution dated 20.04.2002 had made application to the Northern Regional Committee (for short the NRC) seeking recognition to start B.Ed. course with annual intake of 60 students from the academic session 2003-2004, in the name of the institution, namely, Gautam Buddha Degree College, Sahiyapur-Majhila, Kannauj vide covering letter dated 19.12.2002. The required undertaking and sworn affidavit submitted alongwith the application were signed by the said Shri Ram Sanehi.

- AND WHEREAS, the said application was rejected by NRC in its 88<sup>th</sup> meeting for using 06 forged/altered Fixed Deposit Receipts (FDRs) of Rs. 50,000/- in total to Rs. 5,00,000/- (Rs. Five Lacs) in total towards Endowment Fund. Consequent to the said decision, formal order No. F.NRC/NCTE/F-3/UP-874/2005/462-470 dated 13/19<sup>th</sup> April, 2005 was issued by the NRC.
- 3. AND WHEREAS, the above Society- "Adarsh Shiksha Samiti, Sahiyapur, Majhila (Kannauj)", as Managing Society, has now made fresh application in the name of the institution, namely Gautam Buddha Degree College, Sahiyapur, PO Rampur Majhila, Kannauj (UP) 209723 for recognition to start B.Ed. course from academic session 2004-2005. The required Undertaking and Sworn Affidavit etc. are signed by Shri Ram Sanchi S/o Shri Ram Swroop, who is the Manager of the Managing Society. The No Objection Certificate (NOC) issued by the State Government of Utter Pradesh is dated 09.11.2001, which has been annexed with the application form, which cannot be considered as per NCTE Regulations 2002 dated 13.11.2002.
- 4. AND WHEREAS, the NRC in its 90<sup>th</sup> meeting held on 22<sup>nd</sup> & 23<sup>nd</sup> April 2005 has taken a policy decision that new applications received from such institution/societies seeking fresh recognition, who submitted applications in previous years but recognition could not be granted due to submissions of fraudulent/illicgally tempered FDRs/DDs shall not be considered. Consequent to the said decision this fresh application is hereby rejected. Further the NOC of the state Government, on the basis of which the present application is submitted, is dated 09.11.2001 and the same has lapsed as the institution failed to get recognition within three years from the date of issue as per para 6 (v) of the NCTE Regulations 2002 dated 13.11.2002.
- AND THEREFORE, in terms of above decision of NRC, the application of Gautam Buddha Degree College, Sahiyapur, PO – Rampur Majhila, Kannauj (UP) - 209723 seeking recognition for B.Ed. is refused under section 14 (3) (b) of the NCTE Act, 1993.
- 6. Consequently, any examining body shall, on receipt of the order, cancel affiliation of the institution as provided under sub-section (6) of section 14 of the Act. Further, the institution shall not admit any student in B.Ed. course and other concerned body(s) shall not hold examination, whether provisional or otherwise for the B.Ed. course if conducted by the said institution unless the institution is granted recognition for the said course by the NRC/NCTE.

- 7. In accordance with section 17 (4) of the NCTE Act, 1993, the qualification in teacher education, namely B.Ed., obtained pursuant to such course or training in the above institution for purpose of employment under the Central Government, any State Government or University, or in any school, College or other educational body aided by the Central Government or any State Government.
- 8. Further, if the institution is not satisfied by this order, it can prefer an appeal before National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under section 18 of NCTE Act, 1993, within 60 days of the date of issue of this order. The guidelines for appeal are enclosed herewith.
