ORDER

WHEREAS, the Institution, namely, Akashdeep Teachers Training Girls College, Sector-11, Agrawal Farm, Mansarovar, Jaipur has made application for recognition to start Secondary Teacher Education Programme, commonly known as B.Ed. from academic session 2005-2006 and the same was received in the office of Northern Regional Committee (NRC), Jaipur on 30th December, 2004. The same institution has been granted recognition by the NRC vide its order dated October 08,2002 to start Shikshe Shastri (B.Ed.) Course of one year duration from the academic session 2002-2003 with an annual intake of 100 students.

- 2. That vide amending Regulations, 2003 dated 21st August, 2003, clause (IV) of para 8 of the NCTE Regulation, 2002 has been substituted whereby requirement of Accreditation of the institution with a grade of 8st on a 9-point scale developed by the National Assessment Accreditation Council (NAAC) is made mandatory for enhancement of its intake over and above the basis unit as indicated in the Appendices 3-14 of the Regulation and for starting enew course or training in teacher education under Sub Section (1) of Section 15 of the NCTE Act, 1993.
- 3. AND WHEREAS, the applicant institution is not accredited with a grade of B' grade from NAAC, the NRC in its 98th and 99th meetings decided to provide a reasonable opportunity to the institution for making written representation before refusing the above application after being satisfied that the requirement of Accreditation from NAAC is mandatory for the applicant institution. Pursuance thereof, the institution was intimated by the NRC and pursuance thereof, the institution has made representation vide its communication dated January 30, 2006.
- 4. AND WHEREAS, the NRC in its 101st meeting held on 22nd and 23rd February, 2006 after considering the entire matter including the representation made by the institution and after being satisfied that the requirement of Accreditation Certificate of B⁺ grade from NAAC is essential decided to refuse the aforesaid application made by the institution.
- AND THEREFORE, in terms of the above decision of the NRC, the application of the institution for B.Ed. Course as applied for is hereby refused under Section 14(3)(b) of the NCTE Act, 1993.
- 6. Consequently, the institution shall not admit any student in the B.Ed. Course as applied for and the examining body shall not grant affiliation for this course to the institution or hold examination, whether provisional or otherwise, if the said course is conducted by the institution without permission from NRC / NCTE.
- 7. In accordance with Section 17(4) of the NCTE Act, 1993, the qualification in teacher education, namely, B.Ed. obtained pursuant to such course or training in the above institution shall not be treated as valid qualification for purposes of employment under the Contral Government, any State Government or University, or In any School, College or other educational body aided by the Central Government or any State Government.
