ORDER

Moulana Azad Muslim Pre-School Teacher Training Institute, Pal Link Road, Kamla Nehru Nagar, Jodhpur - 342001, Rajasthan submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition of Pre-School Teacher Education course of one Year duration in terms of section 14(1) of NCTE Act, 1993.

- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act. 1993, the Regional Committee hereby grants recognition to Moulana Azad Muslim Pre-School Teacher Training Institute, Pol Link Road, Kamla Nehru Nagar, Jodhpur - 342001, for an annual intake of 50 seats (Fifty Only) in Pre-School Teacher Education course of one Year Duration with effect from 21" March, 2005 subject to compliance of the following before the commencement of the session: -
 - Appointment of the faculty members duly qualified and staff as per the norms of (0) NCTE/ State Govt /UGC is to be completed before the commencement of the
 - The countersigned statement of all faculty members from the Director, SCERT (iii) should be submitted before the commencement of the academic session.
 - The institution shall adhere to all the other regulations and guidelines as framed by (111) NCTE from time to time.
 - The institution shall within one month of the receipt of Recognition order, convert (iv) the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee
 - That the Reserve Fund for an amount equal to three months salary of the Teachers & (v) Staff he created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
 - Non-compliance of the above mentioned conditions shall cause action under section 17 (vi) (1) of NCTE Act, 1993.
 - Further, the recognition is subject to fulfillment of all such other requirements as may be presembed by other regulatory bodies like VGC and State Government, etc.
 - The institution shall submit to the Regional Committee a Self-Approisal Report at the end of each geodemic year along with a cupy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly oudited by a Chartered Accountant
 - If the institution contravenes any of the above conditions or any of the provisions of the NOTE Act, Rules, Regulations and/or order made or issued there under the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
