- Naw, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act. 1993, the Regional Committee hereby grants recognition to Akashdeep Teachers Training Girls. College, Sector-11, Agrawal Farm, Mansarovor, Jaipur - 302020, Rajasthan for an annual intake of 50 seats (Fifty Only) in the 1st year and the same for the 2rd year in 5.T.C. (General) course of Two Year Duration with effect from 21" March, 2005 subject to compliance of the following before the commencement of the session: -
  - (i) Appaintment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./UGC is to be completed before the commencement of the
  - (11) The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session.
  - (111) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (iv) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee
  - (v) That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
  - (vi) Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum that they are going to adopt for the course.
  - (vii) Institutions if starts the training programme without prior approval permission of competent authority / examining body regarding the curriculum they have adopted and conduct of examination for award of Diploma / Certificate the recognition of such institutions shall withdrawn.
  - (vili) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
