## ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act, 1993, NCTE Headquarters conducted inspection of the Sanatan Dharam Sr. Secondary School. Near Gaushala, Thajjar, Haryana on 25.09.2003 and after having received the report / findings from the inspection team and sezking response of the institution on the deficiencies reported by the inspection team, the same were forwarded to the office of NRC to take further necessary action in accordance with the provisions of the NCTE, Act, Rules, Regulations etc. The deficiencies pointed out are as under:-

- (i) The Principal does not possess qualification as per NCTE norms.
- The institution has not furnished the list of teaching staff duly approved by the SCERT, Haryana.
- (iii) The ET lab does not have adequate number of electronic publications on education.
- (iv) The library resources are extremely poor. It has very small number of books on education; encyclopedia is also not available.
- (v) The Institution does not maintain Endowment Fund and Reserve Fund.
- 2. AND WHEREAS, the said report of the inspection team was placed before the NRC in its 80th meeting. Having considered the same, the Committee decided that a Show Cause Notice be issued to the institution under Section 17(i) of the NCTE Act, 1993. Accordingly a Show Cause Notice dated 08.08.2004 was issued to the institution, communicating therein the deficiencies observed by the visiting team on inspection made by it under Section 13 of the NCTE Act, 1993, providing opportunity of making representation against the proposed action.
- 3. AND WHEREAS, the institution did not submit any reply / representation to the above Show Cause Notice. However, reminder dated 20.01.2005 was again sent to the institution which was replied by it vide communication dated 31.01.2005.
- 4. AND WHEREAS, the NRC considered the entire matter in its 88th meeting, including the deficiencies pointed out and intimated to the institution and its reply; the Committee being satisfied that the said deficiencies are of serious nature having adverse impact on the quality of teacher training / education, violating norms and standards laid down under the Rules, Regulations and Orders made or issued under the Act as well the conditions to which recognition / permission was granted to the institution, has decided to withdraw recognition of Sanatan Dharam Sr. Secondary, School, Near Gaushala, Jhajjar, Haryana for running b.Ed, course with effect from the end of the current academic session 2004-2005.

- AND THEREFORE, the recognition of Sanatan Dharam Sr. Secondary School, Near Gaushala, Jhajjar, Haryana for D.Ed. Course stands withdrawn from the end of the current academic session i.e. 2004-2005.
- 6. As a result of this order, Sanatan Dharam 5r. Secondary School, Near Gaushala, Jhajjar, Haryana shall discontinue D.Ed. teacher training course immediately after the academic session 2004-2005 and the concerned University or examining body shall cancel affiliation of the institution in accordance with this order with effect from the end of the current academic session 2004-2005 as provided under Sub-Section (3) of Section 17 of the National Council for Teacher Education Act, 1993.
- 7. The qualification in teacher education obtained pursuant to that course or training or after undertaking a course of training in the said institution after the academic session 2004-2005, shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other educational body aided by the Central Government or any State Government as per Sub-Section (4) of the Section 17 of NCTE Act, 1993.
- B. Further, if the institution is not satisfied by this order, it can prefer an appeal before NCTE. Headquarters against this order under Section 18 of NCTE Act, 1993, within 60 days of the date of issue of this order. The guidelines for appeal are enclosed.
