ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCIE Act, 1993, NCTE Headquarters conducted inspection of Shri Haryana Shekhawati Brahmacharya Ashram, Mehans Gate, Bhiwani, Haryana -127021 on 25.09.2003 and after having received the report / findings from the inspection team and docking response of the institution on the deficiencies reported by the respection team, the same were forwarded to the office of NRC to take further necessary action in accordance with the provisions of the NCTE, Act, Rules, Regulations etc. The deficiencies pointed out are as under to

- It is reported that there is no separate staff appointed for the D.Ed. section and the (1) teaching staff of the attached senior secondary school is being used in the D.Ed.
- The appaintment of teaching statt has not been approved by the SCERT, Haryone, (ii)
- The ET lab dies not have PCs and other equipments required in the lab (111)
- The Psychology lab does not exist (IV)
- The library resources are extremely poor. It has very small rumber of books on education (v) : does but subscribe, educational journals / personicals and encyclopedia is also not available.
- The teacher are being paid meager consolidated soluties in costs which is not in (vi) accordance with the State / Central guidelines.
- The institution does not maintain endowment and reserve fund. (vii)
- AND WHEREAS, the sold report of the inspection team was placed before the NRC in its 80" meeting. Having considered the same, the Committee decided that a Show Cause Motice be issued to the institution under Section 17(i) of the NCTE Act, 1993. Accordingly a Show Equise Natice dated 08,08,2004 was issued to the institution, communicating therein the deficiencies observed by the visiting team on inspection made by it under Section 13 of the NETE Act, 1993, providing appartunity of making representation against the proposed action.
- The reply submitted by the institution was placed before NRC in its 85th meeting, whereby the NRC decided that the institution may submit documentary proof duly certified by the outborized person of the Society (President / Secretary) with each deficiency notified and already conveyed through Show Cause Notice dated 08.08.2004 alangmith un Affidaut by President / Secretary of the institution in support of the documents to be submitted.
- AND WHEREAS, the NRC considered the entire matter in its 89th meeting, including the deficiencies pointed out and intimated to the institution and its reply; the Committee noted that replies are vague and evasive and that the above deflerencies pointed out in the Show Cause Natice still persist. Hence, the Committee under the Rules, Regulations and Orders made or issued under the Act as well the conditions to which recognition / permission was granted to the institution, has decided to withdraw recognition of Shri Haryana Shekhawati Brahmacharya Ashram, Meham Gate, Bhiwani, Haryana -127021 for running D.Ed, course with effect from the end of the current academic session 2004 2005.
- AND THEREFORE, the recognition of Shri Haryana Shekhawati Brahmacharya Ashram, Maham Gate, Shiwari, Haryana -127021 for D.Ed. Course stands withdrawn from the end of the current academic session Le. 2004-2005. Confd. ?

- 6. As a result of this order, Shri Haryana Shekhawati Brahmacharya Ashrom, Meham Gote, Shiwani. Haryana -127021 shall discontinue D.Ed. teacher training course immediately after the accidente session 2004-2005 and the concerned University or examining body shall cancel affiliation of the institution in accordance with this order with effect from the end of the current academic session 2004-2005 as provided under Sch-Section (3) of Section 17 of the National Council for Teacher Education Act.
- The qualification in teacher education obtained pursuant to that course or training or after indertaking a course of training in the sold institution after the academic session 2004-2005, shall not be treated as valid qualification for purposes of enuitoyment under the Central Government, any State Government or University, or in any School, College or other educational body alided by the Central Government or any State Government as per Sub-Section (4) of the Section 17 of NCTE Act, 1993.
- Further, if the institution is not satisfied by this order, it can profer an appeal before NCTE, Headquarters against this order under Section III of NCTE Act, 1993, within 60 days of the date of issue of this order. The guidelines for appeal are enclosed.
