ORDER

WHEREAS, the institution namely Shiva Institute of Management Studies, 364-365. Pandev Nagar Industrial Area, Hulandshahar Road, NIT-24, Ghaziabad (UP)-201005 has made an application to Northern Regional Committee (in short NRC) under section 15 (1) of NCTE Act, 1993 to seek permission to start new course of BTC from academic session 2004-2005 vide covering letter dated January 13, 2004 and the same was received in the office of NRC on January 29, 2004.

- The institution was inspected on 01 12 2004 by an inspection team of expert constituted by NRC. The inspection team noted certain deficiencies in its report submitted and the same was considered by NRC in its 87th indicating held on 28–29 January 2005 alongwith the original file of the institution.
- After careful perusal of the file, inspection report of the experts and other related documents, the Committon in the above meeting being satisfied that the institution did not fulfill the requirements laid down in sub-clause (a) of section 15 (a) of NCTE Act. 1993 decided that the institution be given a reasonable opportunity for making representation drawing its attention with following deficiencies existed vis-a-vis NCTE norms:

 The institution has not provided documentary proof with regards to purchase of equipments/ instruments/ consumable/ books/ journals etc.

(ii) Only 1800 books have been provided in the library for existing B. Ed course. No more books have been added for the BTC course.

Consequently, as per above decision, letter No. F. NRC/NC1E/F 3/UP-1457/2004/13/104 dated 10.02/2006 was issued communicating the above deficiencies to the institution with an apportunity to make representation within one month before passing an order refusing permission to the new course of BTG.

4. The institution submitted its written representation vide letter No SIMS/BTC/05 dated 05.03.2005 which was received in the office of NRC on 07.03.2005. The said representation was placed before the NRC in its 89 meeting held on 21 March 2005 wherein the Committee, after consideration of the entire matter including the deficiencies referred to above, being of the opinion that the institution does not fulfill the requirements relating to norms and standards laid down for the same, passed an order refusing permission to the institution for the new course of B1C.
