ORDER

WHEREAS, the institution, namely, Shri Gopichand Mahavidyalaya, Ahera, Baghpat (UP) 259609 has made an application to Northern Regional Committee (in short NRC) under section 15 (1) of NCTE Act, 1993 to seek permission to start new course of BTC from academic session 2004-2005 vide covering letter dated 29.12.2003 and the same was received in the office of NRC on 30.12.2003.

2. The institution was inspected on 30.11.2004 by an inspection team of expert constituted by NRC. The inspection team noted certain deficiencies in its report submitted and the same was considered by NRC in its 87<sup>th</sup> meeting held on 28-29 January, 2005 alongwith the original file of the institution.

3. After careful perusal of the file, inspection report of the experts and other related documents, the Committee, in the above meeting, being satisfied that the institution did not fulfill the requirements laid down in sub clause (a) of section 15 (3) of NCTE Act, 1993 decided that the institution be given a reasonable opportunity for making representation drawing its attention with following deficiencies existed vis-a-vis NCTE norms:

- (i) The institution has not submitted Sworn Affidavit attested by First Class Magistrate in the required format.
- (ii) Reserve Fund equivalent to three months salary of the staff is not provided.
- (iii) Salary to the staff is not paid through account payee cheque.
- (iv) The institution has procured 485 books only in the library whereas the Committee is of the view that a minimum of 1500 books are required for conducting the BTC course effectively.
- (v) The institution has not provided documentary proof with regards to purchase of various equipments/instruments/chemical and consumable items for the proposed BTC course as per NCTE norms.

Consequently, as per above decision, letter No. H-NRC/NCTE/H-3/UP-1315/2004/13103 dated 10.02.2005 was issued communicating the above deficiencies to the institution with an opportunity to make representation within one month before passing an order refusing permission to the new course of BTC.

4. The institution submitted its written representation vide letter No. SGM/BTC/2004-05/21 dated 09.03.2005 which was received in the office of NRC on 10.03.2005. The said representation was placed before the NRC in its 89<sup>th</sup> meeting held on 21<sup>st</sup> March, 2005 wherein the Committee, after consideration of the entire matter including the deficiencies referred to above being of the opinion that the institution does not fulfill the requirements relating to norms and standards laid down for the same, passed an order refusing permission to the institution for the new course of BTC.

5. AND THEREFORE, in terms of above decision of NRC, the application of Shri Gopichand Mahavidyalaya, Alira, Baghpat (UP) - 250609 seeking permission for the new course of BTC is refused under section 15 (3) (b) of the NCTE Act, 1993.

6. Consequently, the institution shall not admit any student in BTC course and other concerned body(s) shall not hold examination, whether provisional or otherwise for the BTC course if conducted by the said institution unless the institution is granted permission for the said course by the NRC/NCTE.

7. In accordance with section 17 (4) of the NCTE Act, 1993, the qualification in teacher education, namely BTC, obtained pursuant to such course or training in the above institution shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other educational body aided by the Central Government or any State Government.

8. Further, if the institution is not satisfied by this order, it can prefer an appeal before National Council for Teacher Education, Hans Bhawan, Wing-II, I, Bahadur Shah Zafar Marg, Near JTO, New Delhi-110002 against this order under Section 18 of NCTE Act, 1993, within 60 days of the date of issue of this order. The guidelines for appeal are enclosed herewith.
