## ORDER

WIIERFAS, the institution, namely, Shiva Institute of Management Studies 364-365 Pandey Nagar, Industrial Area, Bulandshahar Road, NH 24, Ghaziabad (UP)-201105 has made an application to Northern Regional Council (in short NRC) under section 15 (1) of NGT Act, 1993 to seek permission to start new course of BTC from academic session 2004-2005 vide covering letter dated January 13, 2004 and the same was received in the office of NRC on January 29, 2004.

The institution was inspected on 01-12-2004 by an inspection team of expert constituted by NRC. The inspection team noted certain deficiencies in its report submitted and the same was considered by NRC in its 87<sup>th</sup> meeting held on 29-30 January 2005 alongwith the original file of the institution.

3. After careful perusal of the file, inspection report of the experts and other related documents, the Committee, in the above meeting, being satisfied that the institution did not fulfill the requirements laid down in sub clause (c) of section 13(3) of NCTE Act, 1983 decided that the institution be given a reasonable opportunity for making representation drawing its attention with following deficiencies existed vis-a-vis NCTE norms:

- (i) The institution has not provided documentary proof with regards to purchase of equipment/instruments/consumable books/journals etc.

(ii) Only 1800 books have been provided in the library for existing B.Ed courses. No more books have been added for the DTC course.

Consequently, as per above decision letter No. F-NRC/INCTE/H-3/UI-1457/2004/13104 dated 10.02.2005 was issued communicating the above deficiencies to the institution with an opportunity to make representation within one month before passing an order refusing permission to the new course of B.Sc.

4 The institution submitted its written representation vide letter No SIMS/BTC/05 dated 06/03/2005 which was received in the office of NRC on 07/03/2005. The said representation was placed before the NRC in its 89<sup>th</sup> meeting held on 11<sup>th</sup> March, 2005 wherein the Committee, after consideration of the entire matter including the deficiencies referred to above, being of the opinion that the institution does not fulfill the requirements relating to norms and standards laid down for the same, passed an order refusing permission to the institution for the new course of BTC.

b. AND THEREFORE, in terms of above decision of NRC, the application of Shiva Institute of Management Studies, 364-365, Pandey Nagar, Industrial Area, Bulandshahar Road, NH-24, Ghaziabad (UP) – 201005 seeking permission for the new course of BTC is refused under section 15 (3) (c) of the NCTE Act, 1993.

5. Consequently, the institution shall not admit any student in BTC course, and other concerned body(s) shall not hold examination, whether provisional or otherwise for the BTC course if conducted by the said institution unless the institution is granted permission for the said course by the NRC/NCTE.

7. In accordance with section 17 (4) of the NCTE Act, 1993, the qualification in teacher education, namely BTC, obtained pursuant to such course or training in the above institution shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other educational body aided by the Central Government or any State Government.

8. Further, if the institution is not satisfied by this order, it can prefer an appeal before National Council for Teacher Education, Sans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of NCTE Act, 1993 within 60 days of the date of issue of this order. The guidelines for appeal are enclosed herewith.
